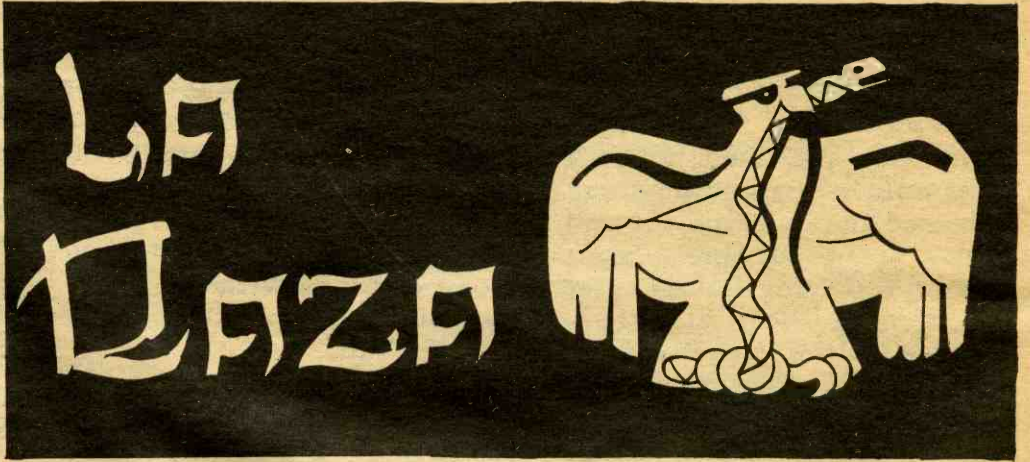

CONTROLLED CONFERENCES

The idea of improving police-community relations by holding "high-level" meetings and conferences is not a new one. The "morgue" of the newspapers is filled with reports of "community meetings" and "police-community relations conferences". This year, on April 22, one of these controlled confer-

FARM WORKERS DEMAND JUSTICE

STRIKE! HUELGA!

On the morning of August 3rd, farmworkers at the Giumarra Vineyards Corporation walked out of the fields with shouts of Viva Nuestra Union! Viva la Huelga! Viva la Raza! and Viva César Chavez!, marking the beginning of the long-awaited drive to win union benefits for over 2,500 field workers.

Most of the workers at Giumarra had signed authorization cards designating the United Farm Workers Organizing Committee (UFWOC) as their bargaining agent with the employer. At a Rally-

Fiesta held on July 23rd for union members at Di Giorgio and Giumarra in Bakersfield, Giumarra workers pledged themselves not to be strikebreakers if the company did not agree to recognize the rights of the workers to a union of their choice.

WORKERS' DEMANDS

At meetings held in Delano and Bakersfield on the night of August 2nd, the workers at Giumarra wrote out their demands in keeping with the contracts the union already has at Schenley, Di Giorgio,



because, after all, this Country (especially the Westward Movement) was founded by Force and Violence and sustained by sheer power, both economic and political.

Take the Westward Movement as a prime example of Force and Violence to accomplish one's aims and ends, for in this Movement the American Indian was totally annihilated because his only means of survival-the Buffalo - was systematically destroyed!

So it ain't no big deal when Newark and Detroit were destroyed because the Power Structure and Establishment were badly shaken because Force and Violence hurt -- where it hurts them the most - in the pocketbook. These o-

ppressed people in Newark and in Detroit were only doing what has been an American Tradition.

Now what about the Mexican? Does he have it made in this Country, especially in the Southwest? Hell no! After 1846 our people were disenfranchised. Our people were victimized out of their lands. Our people were brutalized. Our people, who wanted to mine had to pay a miner's tax.

These wrongs were inflicted by the use of Force, Power and Violence, even though the Treat of Guadalupe Hidalgo guaranteed (or was supposed to guarantee) the Rights of our people.

Why even today our people (continued on page 4)

ences held at the Police Academy was picketed by over 50 people. Even some of the selected guests came out and joined the picket line. Some of those staying inside tried to express their disagreement with the proceedings, but their views were not made public and in some cases they were told to "keep it quiet".

Two days before the Conference, Deputy Chief Inspector James Fisk was told by representatives of several grassroots organizations in the Eastside the objections they had to the conference. After several hours of public relations soft talk by Fisk, it was evident that he had nothing to offer and no power to deal with the real demands of the people. The conference went on as scheduled, the Police "show" went on and, in the streets, frisking, harrassment, name calling, and brutality by the police continued.

NO RIGHT TO DEMAND?

According to Chief Deputy Fisk, the only one who has

the power to make changes in the police department is chief Reddin himself. Chief Reddin has been trying to build his image as a community oriented public official. In reality, Tom Reddin has no more concern with the desires of the people than chief Parker had.

At a community meeting held at the Church of the Epiphany on August 1st, chief Reddin, faced a panel of community people. The panel was composed of Ben Gomez, educator and spokesman; David Sanchez from YCCA, Ray Martinez from Happy Valley, David Chico from Mariana Maravilla, and Elizabeth Mesa from Clover. As soon as the panel presented their demands "el jefe" said, "I don't receive demands, I'm not susceptible to demands, I am here to explain our (LAPD) position." Public response was strong; several people said that Chief Reddin was a public official, and that his salary was paid from taxes, therefore, that he was responsible to the people and that the community had the right to demand the kind of services the police ought to perform. As the chief was unable, or unwilling to satisfy the demands of the people, most of those present walked out and left the chief alone with his plainclothes bodyguards.

JUST DEMANDS

The demands agreed to by the people who organized the meeting with chief Reddin were as follows: 1) That an Executive Order by Chief Reddin be sent to the Commanders and men of Highland Park and Hollenbeck Divisions (and all predominantly Mexican communities) to cease immediately any form of physical violence, harrassment, name-calling and bad treatment by LAPD officers. 2) An Executive Order establishing the principle of equal-protection under-the-law in predominantly Mexican areas: fast response to calls, investigating procedures, information of legal rights to persons stopped for questioning, etc. 3) An Executive Order requiring all officers in predominantly

Mexican areas to take extensive training in the language, history, culture, and prevailing conditions in those communities. 4) The establishment of an advisory committee, elected by a community convention, and not appointed by police, mayor, or any other agency.

OUTSIDE AGITATORS

Councilman Snyder, of Snyder Productions S. A., and his assistant Cid Molina, blamed the response to chief Reddin's lack of answers on "outside agitators". Snyder was born in Lincoln Heights but moved "outside" to Eagle Rock where Mexicans are not allowed to own property or business and still he pretends to "represent" the residents of Lincoln Heights.

The "outsiders" at the meeting with the chief were members of several well known organizations. Present were representatives of the Community Service Organization (CSO), Mexican American Political Association (MAPA) Parents' Councils of Rose Hill, Happy Valley and El Sereno, East Los Angeles Improvement Council, United Council of Community Organizations (UCCO), Neighborhood Adult Participation Project (NAAP), Teen Posts, Social Action Training Center (SATC), and boys from Clover, Happy Valley and Maravilla.

Those were the "outside agitators" Snyder and Molina were talking about. We have not been able to get any specific information from the office of "our" councilman, except the letter informing us that another "conference" has been scheduled.

Make Your Voice Heard

Nothing has changed in the streets. Complaints keep being filed through the ACLU Malpractice Center, unwarranted arrests are being made, name calling continues, and, respect for "law and order" doesn't seem to be the practice of the LAPD. Let's have more justice and less promises.

If you have any complaints against actions by the police, come to Lincoln High Auditorium on September 7, and voice your opinion. Tell it like it is!

POLICE AND EDUCATOR MALPRACTICE

On the afternoon of July 6, officers of the Monterey Park police arrested and booked overnight five Mexican youth on SUSPICION of use and possession of narcotics and theft. The five youngsters were at the time having their lunch hour from the nearby Skill Center at 1260 Monterey Pass Road. Not awaiting for additional information, Supervisor of the Center, Oscar Gallegos, and his Assistant, Dale Gustafson, acted as "judge, jury and executioners" and immediately terminated the five boys only two weeks short of completion of their 17 week training course.

The boys were released the following day for "lack of evidence". Tools found in the automobile, and claimed by the police to have been stolen, belonged to the father of one of the boys. No narcotics were found on their possession, and when the boys demanded a medical examination on the charge of being under the influence of narcotic, the police backed down. It seemed evident at this point as in so many other cases, that the suspicion was based solely on the fact that they were Mexican. The parents of the boys have not taken legal action against the police because of an ingrained habit in our community of a-

voiding the courts, however, taking it to the courts is the ONLY way in which the law will be applied equally to all.

Meanwhile the Gallegos-Gustafson "court martial" methods came into question. Two of the boys, Al Lopez and Al Ramirez, were readmitted when their parents went to see Gallegos, one of them accompanied by an Attorney. The other parents contacted the Educational Issues Committee of the United Council of Community Organizations (UCCO) trying to get their sons reinstated. Gallegos came uninvited to a meeting of the Educational Issues Committee and the parents of the Skill Center trainees. Once there, he tried to justify himself, reading from his black book (administrative guide) and tried to gain the sympathy of the group by explaining the headaches he had keeping the students "in line". According to one of the parents, Gallegos gave the impression that narcotics users hide behind every bush and that he had to check daily, latrines and dark corners.

Only the intervention of Mr. Bill Johnston, Associate Superintendent for Adult Education, forced Gallegos to revise his ruling. Mr. Johnston acted as a result of a

meeting with the parents and delegates of the United Council. The parents wanted their sons to have a certificate of graduation, back pay for the two weeks lost, and a letter of apology. Pete Reyes and Albert Tostado have already received their certificate and one week back pay, while Mr. Johnston has promised that the last one of the youngsters will receive the same as soon as his case is cleared in court September 11.

Many other complaints against the administration of the Skills Center came to light during the meetings with the parents. The Educational Issues Committee is working on the creation of a Community Advisory Council; other Skills Centers in Watts and Pacoima do have Councils, but Gustafson is said to oppose one for the East L.A. Center. Some teachers and students complained of the "prison camp" atmosphere and "correctional" style of discipline as practiced by Gustafson. Others spoke of preferential treatment, lack of materials, too many administrators and not enough teachers, inadequate training, and high rate of dropouts. It seems as if the administration does need an Advisory Council to help them run the school.

Cities are burning! The people blame the police, the police blame the people; Congress blames OEO; OEO blames Congress; the Republicans blame the Democrats; the Democrats blame the Republicans--and the poor live in hell. Who cares where the blame lies? Change is the important thing. Change in the community, change that brings more jobs, more dignity, more education, and more of the good things of life to the pobre desgraciado. This change comes from community action and action comes from organization and unity. The Community Service Organization (CSO), means organization and unity. This summer, CSO--with the help of an OEO grant--trained and sent out into the community approximately 120 youths from the ages of seventeen to twenty-four with the message, "Unite!"

acquainted with the problems in the community, to determine ways of attacking and solving some of those problems, and to familiarize the residents with services available in the area. The many problems facing residents in the target area seemed to be mainly in the areas of economics, politics and welfare. Lack of job opportunities and training resources, credit, insurance, high prices and poor quality of merchandise, deficient housing, and transportation appeared to be the most pressing economic problems of the area residents. The political disenfranchisement among the poor of the area was evident in the lack of participation in the local government, political or civic action groups, almost complete ignorance of avenues of redress of grievances, and low percentage of voter registration.

The training of the young adults consisted of a series of speakers on a variety of subjects, from Father Luce of the Parish of East Los Angeles on organizing, Jim Solis of the East Los Angeles Peace Information Center, to Chief Reddin of the LAPD, and Julian Nava from the Board of Education. They were exposed to both establishment agencies such as the Board of Supervisors, the Sheriff's Department, Operation Headstart, and to grass roots organizations such as the Town-Hall Meeting, Young Citizens for Community Action and the Social Action Training Center. Also they observed and participated in anti-poverty activities in the community.

It was hot walking the hills of Lincoln Heights and Happy Valley. It felt, as was evident by the faces and comments of the returning trainees, twice as hot and even more frustrating after a few hours of selling ideas to a community that you understand needs help, but doesn't seem too anxious to jump at the "opportunity" an eager young organizer offers them. Maybe the summer is too short a time for this project to have a real impact in the community, but if only a minority of the youths involved begin to understand people and learns to motivate and activate them, and develops a long range commitment to change through action in their own community, the project will have been a success. A measure of success was reported by Tony Rios in the increased number of calls for aid received by CSO immediately after the house calls began.

After several weeks of lectures, discussions, field trips and rallies, the youngsters went into the field to do door-to-door canvassing and set up house meetings. The purposes were to become better ac-

ECHO-PARK YOUTH ...ON THE MOVE!

The Echo Park - Elysian Teen Post located at 1908 Echo Park Ave. has been headquarters for some exciting goings-on during this past summer. Both adults and youngsters have been working towards the common goal of providing meaningful activities for the youth of the area.

The first goal was to provide summer jobs for young people. A delegation of 50 mostly Mexican-American youngsters spoke with members of EYOA Board of Directors in order to institute this program. Help was also obtained from Sylvia Madrid of the Echo Park Action Committee. Father Moreno of Holy Rosary and Father Andrew Orozco of San Francisco de Assisi. As a result 10 youngsters are working at the Echo Park recreation Center, 6 at the Teen Post itself, and an indeterminate number at various other agencies.

Several Social Activities were planned and carried through. These included a trip to Hermosa Beach by some 22 teen post youngsters, participation in the Outward Bound program for camping in the Sierras, and a group trip to Disneyland.

A series of educational activities are being planned

Classes in sewing, with the help of the Singer Sewing Co; office machine training, with the help of the IBM Co; classes in self-defense and Karate, with the aid of volunteer Art Espinose; scientific body building and boxing. Many other forms of training are being planned.

Some adults in the community have also become involved in helping youngster handle problems of "police brutality". Some lawyers and civic leaders have been contacted and seem to be ready to help.

Because the present Teen Post is housed in a condemned building, the staff is looking for a better site. Also, a Rummage sale is being or-



ganized to finance some of these new activities. If you want to help in any way, contact Director Bob Ramirez, Ass. Director Merle Dubkin or Adult Aid Fran Gomez at 1908 Echo Park Ave. or telephone 666-9963.

The demands were immediate recognition of UFWOC as their bargaining agent, a contract between UFWOC and Giumarra, \$1.90 minimum wage, job security in the form of seniority, health insurance for their families, a grievance committee, paid vacations and holidays, and rest periods on the job. Workers in the cities have had these benefits and more for years, but they have been denied farmworkers by the greed and unlimited power of the growers.

Giumarra's response to the strike was swift and typically ruthless. On August the 3rd 70% of the workers were not in the fields, they were on the picket line. By the second and third days some of the operations at Giumarra had to be closed down. Then the fight began. Armed guards were imported to provoke the strikers to break their pledge of non-violence. Giumarra obtained an injunction from friendly courts to limit the number of picketers in the lines and the places they could picket.

At the same time, workers from other ranchers were "loaned" to Giumarra, trying to divide the local workers. Green card nationals from the Coachella Valley and Mexico were bussed in, bringing Mexican worker to fight Mexican worker. Unemployed Negroes from Bakersfield were brought in, introducing an element of division between Negro workers and Mexican workers. The company even brought school children to the fields.

The Giumarras were informed by the union of the fact that most of their workers had signed for the union and were ready to negotiate. Before any answer was given, the union was informed that at a secret meeting of Giumarra and other Bakersfield area growers an agreement was made to help Giumarra for as long as he didn't "sell out" like Schenley and Di Giorgio had done.

César Chavez and some Giumarra workers met with the representative of Giumarra, Mr. Fike of Western Employers Association. He was not interested in negotiating but in gaining time for the employer to prepare to fight the Union. Within a week, it became clear that the Company was not going to negotiate and the Union took the following Pledge: "The next time the Union sits down with Giumarra it will be to sign a contract."

Giumarra is not a man, Giumarra is an agribusiness corporate monster. Under the names Giumarra Brother's Fruit Co., Giumarra Farms Inc., and Giumarra Vineyards Corp., the Giumarra family has a business worth well over \$25,000,000. Giumarra sells over 1000 railroad box cars and 400 truck loads a year, mainly grapes, cotton, prunes, and potatoes. GVC also has a winery with a storage capacity of 4,000,000 gallons. They also receive 1/6 of the earnings from several oil wells.

the land

Giumarra owns at least 12,170 acres; 6340 acres of grapes, 1600 of cotton, 1450 of potatoes, 480 of oranges, 80 of barley, 320 of various other crops, and 800 fallow acres. Their land holdings spread throughout the southern San Joaquin Valley, but includes lands in the Imperial and Riverside counties. Giumarra also rents or leases over 3700 acres from 18 different ranchers.

the workers

Giumarra Farms Inc. and Giumarra Vineyards Corp. has almost 1000 permanent workers and over 2500 at harvest peaks. Most of the workers make only about \$1.40 per hour. The yearly payroll is \$2,500,000. If Giumarra were to pay the same as Schenley, namely \$1.75, the difference would be \$625,000. Giumarra SAVES \$625,000 every year from unpaid wages.

According to the Congressional Record of July 19, 1967, Giumarra received 246,882 last year for "Soil Conservation", that means for not planting; plus an undetermined amount in loans. The company also saves millions of dollars because they irrigate thousands of acres paying for the water the same price established by law for ranchers who own only 160 acres.

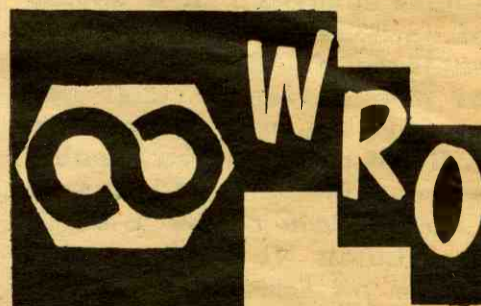

The United Farm Workers Organizing Committee has called for a nationwide boycott of all the products of the Giumarra Fruit Corp. Union representatives are already at work in many of the large metropolitan areas of the U. S. and Canada, trying to organize support from unions, churches, civil rights, and civic action organizations; this same coalition brought Schenley, Di Giorgio, and Perelli-Minetti to the bargaining table. Over 3,000 stores, across the nation have already agreed not to handle Giumarra products.

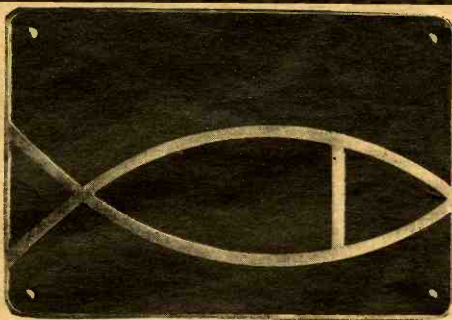
Los Angeles is one of the main centers of distribution for Giumarra products. The value of sales is over a million dollars a year. Most of the potatoes from Giumarra Farms are sold through the firm of Charles Gilben in Los Angeles; and many local stores sell brands of Giumarra grapes; California's Finest, Arra, Uptown, GVC, Grape King, Mr. G., and Honey Bunch. PEANUT BUTTER CONSPIRACY

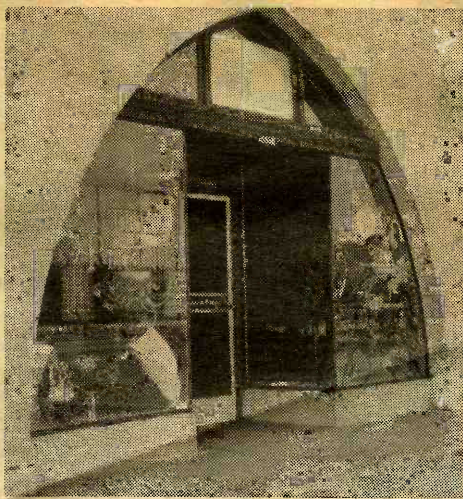
"Our kids need hot food too, and, by God, we are going to get it," says the mother of one of the students at the Glenn Alta School in Rose Hills. Nell Sparks is angry because of what she sees as "skullduggery" on the part of some public officials. But she is not alone in that feeling; many other mothers in the area also feel betrayed by the Board of Education.

Last spring a group of parents met with the principal to talk about how to improve conditions in the school, and after some very bureaucratic "reading of the book of rules" were referred to the Superintendent of Schools. Those same parents, (Mrs. Lopez, Miranda, Valenzuela, De Billie, and Sparks), with help from the Social Action Training Center (E. L. A. SATC) and from NAPPAids, demonstrated, petitioned, and made formal presentations on TV and before the Board of Education.

Since the Piranya is a non-profit organization, any profits made will go into plans for improvement of the Coffee House itself. The young people will make all the plans for what happens there.

On April 24, they came out of a meeting of the Board of Education under the impression that their kids would get a 'hot lunch', and maybe even a cafeteria. At the end of the year the kids were still getting a "peanut-butter-sandwich-stick-of-carrot-in-a-paper-bag" type lunch for 35¢. A member of the Board referred to the bag lunch as an "experiment", while another member of the Board said, "protest or you won't get anything but peanut butter. 'Maybe that's what we will do,'" said one of the mothers, "as a matter of fact we are meeting already and we will move as soon as school opens again."

EDUCATION in LOS ANGELES

- 40% of the pupils in Los Angeles Schools are Black or Mexican-American.
- The average enrollment in predominantly White schools is 750 pupils.
- The average enrollment in predominantly Black and Mexican-American schools is 1058.
- Only 15% of teachers are Black or Mexican-American
- Only 9% of the administrators are Black or Mexican-American.
- Federal and State funds are available for free lunches if the school system request them.
- "If you can't pay you don't eat"; hence, 1/2 the schools in poverty areas have no cafeterias.

- In Compensatory Education, a Federal Program primarily for Black and Mexican children; the twenty-five or more people in policy making positions are all white.
- Twenty of the twenty-four schools most vulnerable to earthquakes are in minority areas.

- Veinte de las veinticuatro escuelas más susceptibles a los terremotos están en comunidades mejicanas o negras.

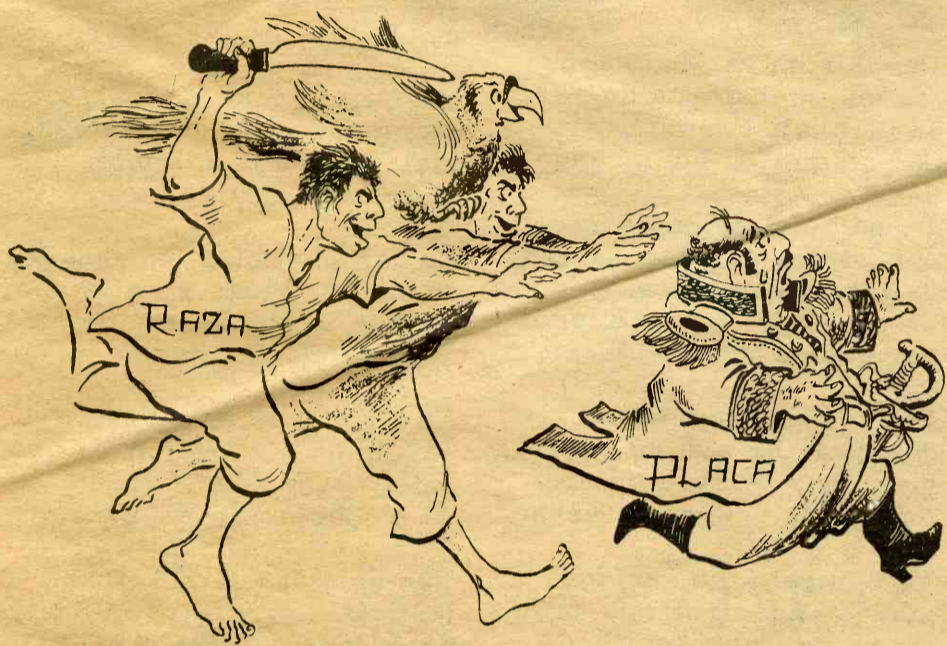

EL PUEBLO DE NTRA. SEÑORA LA REINA DE LOS ANGELES



En éste año de 1967, el 4 de Septiembre es una fecha de doble importancia. No sólo es el día del trabajo sino que también es la fecha en que tradicionalmente se celebra la fundación del Pueblo de Nuestra Señora de Los Angeles en el año 1781. Sería bueno refrescar nuestra memoria y considerar quienes fueron los fundadores reales de la ciudad de Los Angeles. Eran doce hombres y sus familias que hicieron ese viaje histórico originado desde Sonora y Sinaloa hasta llegar al sur de California. Ellos eran:

- 1) José de Lara--un español con 50 años de edad; mujer india y 3 hijos.
- 2) José Antonio Navarro--un mestizo con 42 años de edad; mujer mulata y 3 hijos.
- 3) Basilio Rosas--un indio de 62 años de edad; mujer mulata y 6 hijos.
- 4) Antonio Mesa--un negro con 38 años de edad; mujer mulata y 2 hijos.
- 5) Antonio (Felix) Villavicencio--con 30 años de edad; mujer india y un hijo.
- 6) José Vanegas--un indio con 28 años de edad; mujer india y un niño.
- 7) Alejandro Rosas--un indio de 19 años de edad; mujer india.
- 8) Pablo Rodriguez--un indio con 25 años de edad; mujer india y un hijo.
- 9) Manuel Camero--un mulato con 30 años de edad; mujer mulata y 5 hijos.
- 10) Luis Quintero--un negro con 55 años de edad; mujer mulata y 5 hijos.
- 11) José Moreno--un mulato con 26 años de edad; mujer mulata.
- 12) Antonio Morinda--"chino", español con mezcla de negro, con 50 años de edad; un hijo. Nunca llegó a Los Angeles.

Los historiadores dicen que de los once pobladores, ninguna sabía ni leer ni escribir, que solamente dos podían reclamar antepasados españoles pero que no eran españoles puros, y que de los 22 niños, solamente dos indios eran de ascendencia pura. Quizás era esa realidad étnica lo que inspiró a el intelectual Mexicano José Vasconcelos a escribir su libro "La Raza Cósmica".

Mucho tiempo padecimos la esclavitud del vendido, hasta que al fin todos vimos nuestro triunfo consedido.

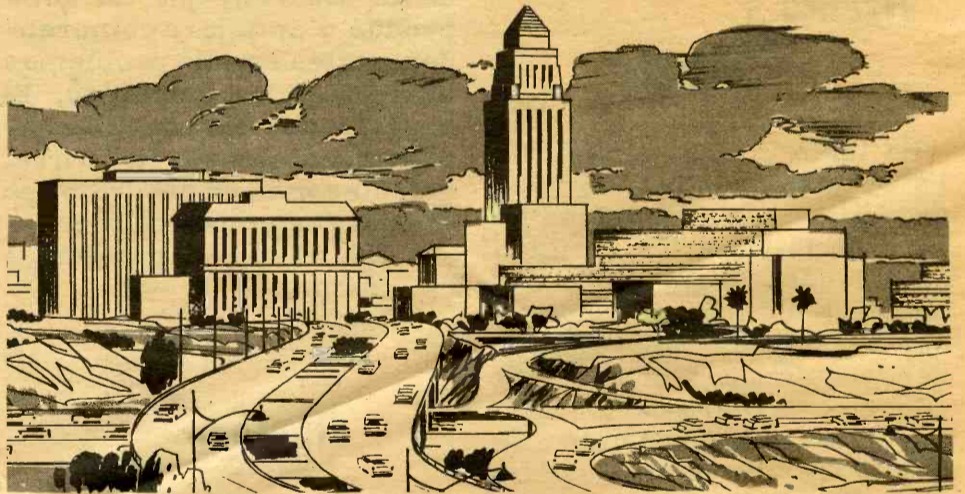

QUIEN ES GIUMARRA ?

Giumarra no es un hombre Giumarra es una asociación comercial con los nombres de Giumarra Brother's Fruit Co., Giumarra Farms Inc., y Giumarra Vineyards Corp. El valor de estas tres compañías sobre pasa \$25,000,000 de dolares, Giumarra vende mas de 1000 carros de ferrocarril y mas de 400 camiones cada año cargados principalmente con uvas, algodón, ciruelas y papas. Tienen también una vinería con una capacidad de 4,000,000 de galones de vino y reciben 1/6 de las ganancias de varios pozos de petróleo.

LA TIERRA

Los ranchos de Giumarra ocupan mas de 12,170 acres,

de los cuales 6340 son de uva, 1600 de algodón, 1450 de papas, 480 de naranjas, 80 de centeno, 320 de otras cosechas y 800 acres baldíos. Por lo menos tiene alquilados 3700 acres alquilados de 18 personas diferentes. Sus ranchos están localizados principalmente en la parte sur del Valle de San Joaquín pero también tienen ranchos en los condados de Riverside e Imperial.

BENEFICENCIA PUBLICA

El Congressional Record del 19 de Junio de 1967 dice que Giumarra recibió \$246,882 el año pasado por no sembrar algodón o para "la conservación de la tierra". La compañía también ahorra millones de dólares porque irrigan sus miles de acres con agua por la que pagan el mismo precio que la ley establece para rancheros que tienen solamente 160 acres.

LOS TRABAJADORES

Las corporaciones de Giumarra emplean casi mil trabajadores permanentemente y mas de 2500 durante la cosecha. La mayoría de esos trabajadores del campo ganan solamente \$1.40 la hora y el presupuesto para salarios es de \$2,500,000. Si Giumarra le pagara a sus trabajadores lo mismo que la compañía de Schenley, esto es \$1.75 la hora, la diferencia sería de \$625,000. Giumarra se ahorra y los trabajadores PIERDEN \$625,000 al año.

735 familias en Delano y en Bakersfield están en Huelga, luchando por una vida mejor para sus hijos y para todo el trabajador del campo. Ellos necesitan de continuar viviendo, entonces ellos van a necesitar dinero y comida. Aquellos que tienen ya una vida mejor deben ayudar al que lucha para alcauzarla.

PLAN DE LAS UNIONES PARA LA ACCION CIVICA EN EL BARRIO

Muchos mexicanos pertenecen a uniones laborales o sindicatos pero, hasta ahora, no se les ha dado la oportunidad de trabajar en forma organizada para el mejoramiento de la comunidad.

El Labor Community Action Advisory Board (LCAAB), que cuenta con la cooperación de once uniones internacionales, está haciendo planes para organizar un proyecto similar al que han tenido en Watts durante los ultimos tres o cuatro años. El programa incluye recreación, artes y artesanía, historia y cultura, construcción de parques vecinales, y entremamiento como lideres para niños y jóvenes desde los 7 hasta los 24 años.

Joe Ybarra, agente de negocios de la Local #26 de la Unión de Estibadores y Almacenistas (ILWU), es miembro de un sub-comité que incluye a Bud Simmonson de la Unión de Empacadores (UPWA) y a Paul Schrade de la Unión de Automovitistas (UAW). Ybarra nos ha informado que la planificación y está bien avanzada y que quizás se ponga en ejecución en menos de un año.
